SERIE(i) **GREEN** DIAMOND SERIES COVERAGE: 5 YEARS(DURATION) **PARTS WARRANTY(ii)**, 10 YEARS(DURATION) **POWER TRANSFORMER WARRANTY(iii)**

SERIE(i) **RED** DIAMOND SERIES COVERAGE: 5 YEARS(DURATION) **PARTS WARRANTY(ii)**, 10 YEARS(DURATION) **POWER TRANSFORMER WARRANTY(iii)**

This warranty is contingent upon the following: (1) the product is installed and operated in accordance with generally accepted industrial standards and in accordance with the printed instructions provided by Green Energy Concepts, Inc. (2) the product is used under normal conditions for which it was designed, (3) the product is not subject to misuse, negligence, unauthorized hardware/software modification, or accident, (4) the product received proper care, protection and maintenance under the supervision of competent personnel and (5) the charger is installed and used in Canada or the United States of America.

PARTS WARRANTY (ii)

Each battery charger part is warranted for the duration of the **PARTS WARRANTY** according to the charger's series (i), beginning from the date of manufacture of the unit, subject to the exceptions listed below. Green Energy Concepts, Inc. does not provide labor or other service expenses, and Green Energy Concepts, Inc. is not obligated to reimburse the owner or any other person or organization for any service performed.

PARTS WARRANTY (ii) EXEPTIONS :

- A. A.C. & D.C. fuses A.C. and D.C. are not warranted unless found to be defective upon initial installation.
- B. No warranty applies to damaged power cables, output connectors, or any damage done by overheating of the output cables or connectors.
- C. Charger enclosure damage or internal damage caused by enclosure physical/mechanical damage.
- D. Damage due to electrical grid supply fluctuation or defect.

POWER TRANSFORMER WARRANTY (iii)

Power transformers with an input of 60hz are warranted for the duration of the **POWER TRANSFORMER WARRANTY (iii)** according to the series of the charger, starting from the date of manufacture of the unit. No labor or other service expenses are provided by Green Energy Concepts, Inc., nor shall Green Energy Concepts, Inc. be obligated to reimburse the owner or any other person or organisation for any service performed.

1. **NON TRANSFERABLE WARRANTY.** This warranty is extended by Green Energy Concepts, Inc. only to the original user (purchaser) of new equipment from Green Energy Concepts, Inc. or one of its authorized selling organizations. The products purchased under this agreement shall be used exclusively by the buyer. This warranty shall have no third-party or beneficiary.

2. **REPAIR LIMITATIONS.** The existence of claimed defects in any product covered by this warranty is subject to Green Energy Concepts, Inc. factory inspection and judgment. Green Energy Concepts, Inc. liability is limited to the repair or replacement of defective products found by Green Energy Concepts, Inc. or its authorized service centers. Return the defective product pre-paid to Green Energy Concepts, Inc. Replacement and exchange parts will be warranted for the remainder of the original Green Energy Concepts, Inc. Industrial Battery Charger Limited Warranty period or warranted for a period of ninety (90) days, whichever is greater. Green Energy Concepts, Inc. and its authorized service centers shall not be liable for direct or indirect damages in excess of such repair or replacement. In no event shall the purchaser be entitled to recover for contingent expenses resulting from, but not limited to, telephone calls, telegrams, travel expenses, lodging, duties and taxes, labor, rental or replacement equipment, batteries, loss of business or profits or other commercial losses.

3. This warranty does not apply to a charger used in a shop supply, service purpose, mine or in mining operations,

4. **CONTINUED USE OF DEFECTIVE PRODUCT.** The continued use of a Green Energy Concepts, Inc. industrial battery charger that is known to be defective **VOIDS ALL WARRANTIES.**

5. **REPAIRED OR MODIFIED EQUIPMENT.** Except as authorized in writing, the warranty specified does not cover any equipment that has been repaired by any party other than Green Energy Concepts, Inc. or its authorized service centers. Except as authorized in writing, the warranty specified does not cover any equipment that has been modified, mechanically or electrically, by any party other than Green Energy Concepts, Inc..

6. **WARRANTY EXPENSE LIMITATION.** Green Energy Concepts, Inc. shall limit the warranty expenses for all chargers to be paid at a maximum of the original purchase price of the charger.
